All participants are responsible for setting up tents, booths, etc. prior to the starting time of the event no later than an hour prior to start time. **Participants agree to the following conditions:**

Release and waiver of St. Stephen AME Church from any and all liabilities as it relates to any act incurred relating to the participation, preparation, sell, consumption and distribution of any products sold at the event. Furthermore, the participant agrees to release St. Stephen AME Church of any bodily claims/damages accidental or otherwise, that may occur as a result of engaging in any activity occurring on or around the Church grounds/facilities.

Event is a “Barbecue Cook-off” meaning it is a competition to determine the “BEST BARBECUE” as voted on by the public. “Barbecue” (ribs, brisket, etc.,) is the main feature designated for the venue. Participants must submit a menu for approval. Sides and other dishes are to be selected by participants. Participants must submit pricing plan for plates and/or for individual items. Participants must adhere to safety and sanitary practices in the handling and serving of food. Participants must receive approval from the designated representative of St. Stephen in order to reserve a booth/space.

Proceeds from the sale of food will be split 65% to the Participant/vendor and 35% to St. Stephen. Sale of and use of alcoholic beverages is not allowed on the premises. Smoking is not allowed on the premises. Firearms are not permitted on the premises.
